

INFORMATION ABOUT PROCESSING PERSONAL DATA

Our esteemed customers, guests, passengers and business partners,

According to Law No. 6698 on the Protection of Personal Data published in the Official Gazette Dated 07.04.2016 and Numbered 29677 ("KVKK"), your personal data provided by KVKK within the limits specified by KVKK and for the cases stated in KVKK may be processed by our Company named Unifree Duty Free İşletmeciliği A.Ş. as "Data Controller" role.

In the duty-free sales shops that are operated by our company ("Shops") making sales in accordance with the Customs Law and Customs Regulations numbered 4458's provisions which covers Customs Warehousing and the related articles of Duty Free Shops Regulation published in the Official Gazette dated 13.10.2006 and numbered 2631 B's Tax Procedure Law numbered 213 and, including but not limited to, competent administrative authority's resolutions and instructions and other legislation provisions ("Legislation") that concern Shops.

According to the legislation it is mandatory to; issue Sales Document for each sale in Shops, and write to the Sales Document that name and surname of the people ("Beneficiaries"), who have the right to buy from Shops, boarding pass or passport number of the passengers who will go to abroad, passport number of the passengers who came from abroad, landing card number or passport number of the transit passengers with the other passenger and sale information ("Personal Data") that Legislation requires and keep the Sales Document for the time that Legislation stipulates.

In order to fulfill our legal obligations stipulated in the legislation, the Personal Data of the Beneficiaries are acquired, recorded, maintained, analyzed by means of automated systems, classified, and when necessary and/or allowed by the Legislation are disclosed to the third parties, administrative and public authorities, and

Due to legislation and airport safety regulations, it is stated that the stores have closed circuit camera systems and that the people in the stores are continuously and regularly recorded with cameras, and

The collection method of the Personal Data is when Beneficiaries buying stuff, the passports and boarding passes of the Beneficiaries pass through passport reader and recording them into Sales Document with gathering it in written and electronic environment, taking footage of them with the closed circuit camera record system, and

Applying to our Company within the scope of KVKK you have the rights about your personal data to; learn whether they are processed; request information about it if it has been processed; learn the purpose of the process and whether it is being used appropriately for its purpose; know the third parties to be transferred in or out of the country; request notifications of transactions made to the third parties to which they are transferred; if they are missing or incorrectly processed; want to be deleted or destroyed in the event that the reasons about the processing disappears; request that third parties

to whom your personal data is transmitted are notified of the transactions made; appeal against the appearance of a result to your detriment by analyzing it exclusively through automated systems and to claim for elimination of the damages in case you are damaged due to the violation of KVKK,

We are informing you about the abovementioned with the role of "Data Controller" in the scope of KVKK.
